1.0 Introduction; Future World Business College (Future World) is non government college registered by National Council for Technical Education (NACTE) bearing registration No *NACTE REG/BTP/040P*, prior to this registration, in 1997 it was registered by Vocational Education and Training Authority (VETA) as *FUTURE WORLD VOCATIONAL INSTITUTE* Reg. No; *VTC/313/2001* courses offered under this authority are as listed on the index page. Also in 1998 the Police Commanding Officer, Traffic Command registered this college as *FUTURE WORLD DRIVING SCHOOL* to train driving courses, and in 2014 the commanding officer again, registered this school to train drivers who wish to upgrade their driving licenses e.g. Driving license class C, C₁ C₂ C₃ & E. This legal recognition of the college enables the college to offers a range of courses categorized as short, long and tailor made programs see the index page. All 3 months and above duration courses involve theory and practical trainings in our classrooms, workshops, kitchens etc plus field attachment to various work places.

2.1 Field Attachment

The college has developed a firm relationship with different organizations which they are always ready to accommodate our trainees for practical training in their organizations. However, we are insisting a trainee and his/her parents to take the responsible on finding an organization for practical attachment at his/her convenient location. The institute will provide all the necessary support e.g. letter of introduction to industries/organizations for this purpose.

2.2 Fee Payment And Other Charges

a) All students taking 3 months courses, apart from paying fee, will have to pay ten thousands T.shs only (10,000/=) for the Identity Card,

b) Optional costs; Hostel; The decent shared rooms, rented at 30,000/= per month per student are available (hostel fees could change from one semester to another), and it is estimated that, an average of 5,000/ per day can be spent by a student for meals at the institute's canteen. Breakfast 1,000/=; Lunch 1,500/=; Dinner ...1,500/= Drinking Water/soda 1,000/=
